Merry Christmas & Happy New Year

The NEA will be closed on Tuesday, December 25th for the Christmas Holiday & on Tues, January 1st for the New Year's Holiday.

ATTENTION MEMBERS....

NEA will not connect your new service or upgrade without an electrical wiring permit.

From the Wyoming State Fire Marshal's office:

An electrical wiring permit is required anytime the electrical utility needs to connect, disconnect and restore electrical power to a building, mobile home or any premises. The person or contractor, installing the electrical wiring is responsible for obtaining the wiring permit. **An electrical utility may not energize the electrical service before said utility has proof that an electrical wiring permit has been obtained.** A wiring permit is required before work is started. Therefore, the contractor or the owner should make sure this office has received the permit, before starting work. It will allow the utility to connect power without delay.

Obtaining a wiring permit allows the electrical inspector to inspect the project if they wish. They have many projects and may not inspect every permit taken out. If you wish to guarantee an inspection, you must request an inspection. For this service there is a separate fee, which is listed on the permit. In either case, all violations to the National Electrical Code will be required to be corrected.

Nebraska requires permits and inspections at various points along the project, and your service will not be connected until we have received a permit from a licensed contractor, or an approved inspection from the state inspector.

Be sure that your wiring project is done by NEC code and all state and local rules.



Phones are answered 24 hours a day. Phones will be answered by Niobrara Electric Association during office hours and the Niobrara County Sheriff's office will take all other calls and dispatch NEA personnel.

One of the behind-the-scenes parts of the electrical system that we work with is called line protection. It is made up of electronic devices that look at the power lines and tell other equipment to shut down the line if it detects a problem and then energize it again to see if the problem went away. Earlier this year we had problems with one of these devices that feeds the Hat Creek and Lance Creek subs, as well as some of our pump station loads. When the device would see a problem, maybe a lightning strike on the line, it would shut off the power, and not turn the power back on. We would have to call out a line crew to the station, close a breaker and patrol the line to find the problem.

As a part of the ONEOK project, we are going to replace this equipment with more modern equipment that will not only tell the system that there is a problem, but it will give an approximate distance to the location of the problem. Given the fact that there are 70+ miles of mostly cross country transmission line on that circuit, this will cut down on the time it takes the NEA crews to patrol the line to find the problems. It will also help to pinpoint causes of nuisance faults like cracked insulators. After discussions with ONEOK, they agreed to pay the \$50,000 price tag to upgrade the system that will improve electric service to their pump stations, as well as about 1/3 of all NEA customers.

This new system is only capable of looking at the transmission lines, not the distribution lines, so it is still very important for you to call in when you have an outage, and if you notice something that might be the cause, be sure to let us know.
