## Fires, Fires, Fires!

As many of you are aware there were recently some large fires in the Harrison, Crawford, and Chadron areas. The "Douthit Fire" burned much of NEA's Northeastern territory, destroying 61 poles. This fire burned through the brand new ten miles of line that was built on the Cottonwood Tap earlier this year, and amazingly, none of those poles burned down, thanks to good right-of-way clearing and the turned dirt at the bottom of each pole. Our linemen, with the help of Ward Electric, were able to replace all burned poles and line to restore power to the affected consumers in a timely manner. Great job guys! Our line crews replace poles, insulators, and other equipment every working day, many times that work is completed without any customers ever noticing because they have the equipment to do their jobs in a way that they don't need to turn off the power to work safely. They actually work on the lines energized at over 14,000 volts. I don't know about you, but I don't like to work on household wires at 120 volts without disconnecting the power source. Occasionally the crews make the decision that they can't safely do what is needed to make repairs with the line energized, so they de-energize the line to complete the job. This is when members notice that the crews are out there. We appreciate your patience and understanding during the times where we have no choice but to shut off the power to work safely.

I would like to take a moment and thank my employees for the award that you see pictured on the front page of the newsletter. NEA completed 2011 with over 83,000 hours of work with no lost time accidents. In an industry where there are a lot of opportunities for different types of workplace injuries, it takes an employee group that is attentive to those risks and willing to take the steps necessary to avoid putting themselves into harm's way to keep up a record like that. By the time this article is in your hands, we should be nearing the 3 year mark since our last lost time accident.

I have seen a quote that goes something like this... Life is like baseball, it's the number of times that you make it home safely that counts. Try to keep that in mind as you go about your work and fun.
