**EXAMPLE**

**CAPITAL CREDIT STATEMENT**

The capital credit earnings reflected on this statement represent your share of the operating margins realized by your cooperative for the year indicated. These margins have been equally allocated to all participating members based upon total dollar billing or usage.

These margins (payments in excess of expenses) become patronage capital and are used by your cooperative for operating capital, necessary reserves, storm damage, and other contingencies. The amount credited to your account may in the future be paid in full or in part. Should the Board of Directors determine that a refund of patronage capital credits be made, they will be refunded in accordance with the by-laws of the Cooperative.

Should you cease to purchase electric service from the cooperative and change your present address, you should notify the cooperative of any address changes. By so doing, you will be assured of receiving your refund check if and when a refund is made.

The other big news from the past month would have to be the weather in May. Yikes! NEA got through all of the snow and flooding with minimal damage, a dozen or so poles damaged from the flooding in spots where we were close to the creek beds. The initial challenge of the flooding was how to just get out of town. With the repairs made to the places we could access by mid-day, the crews set to work assisting the Town of Lusk to make repairs on their system and get as much restored as possible. In at least one case, we were able to use our contacts and personnel to help locate a transformer that is fairly unique to the small municipal utility, allowing the town crews to keep on the more major tasks.

I was glad to see the outpouring of support from local folks and from outside our area offering assistance in the cleanup or offering supplies, clothes or whatever they could. Cleanup from the flooding will continue to take time, my thoughts and prayers go out to those affected by the mess.
