# NOTICE TO MEMBERS OF NIOBRARA ELECTRIC ASSOCIATION OF PROPOSED INCREASES AND DECREASES TO RETAIL RATES TO TRACK REVISIONS IN SUPPLIER'S WHOLESALE RATE BY NIOBRARA ELECTRIC ASSOCIATION

You are here by notified that Niobrara Electric Association (NEA) proposes to make the following changes in its tariffs to become effective January 1, 2019. The changes proposed will result in an overall annual increase of approximately \$141,297 in annual revenue or 1.12 percent average increase overall based upon the test period twelve months ending December 31, 2017. The purpose of these revisions is to coincide with increased operational costs. The proposed rate increase for each rate class is stated below.

Phones are answered 24 hours a day. Phones will be answered by Niobrara Electric Association during office hours and the Niobrara County Sheriff's office will take all other calls and dispatch NEA personnel.

Our contractor, Ward Construction, has completed work on the Lance Creek to Manville line recently and has assisted us in increasing the clearance on the 69kv line up by HWY 270 and HWY 85 to allow safer passage for the high loads that will be passing through over the next couple months.

We also had them take care of the maintenance issues that came up on the 69kv line between Lusk and the breaks that we had patrolled by drone a couple months ago. They are soon to be working on the 69kv line south of Node. We have them doing all of the work on the 69kv lines since they have better equipment to work on the taller poles that are involved.

After they get all of the odds and ends projects cleaned up, they will be headed to work on the next work plan project on the list. We are rebuilding or relocating a good portion of the line feeding around Van Tassell and back towards Node. As with the bulk of our work plan projects, we are focusing on improving the lines that feed the most members, and provide back up support for another substation.

It is critical to have those lines be as solid and strong as we can. If you recall a few years back, we had some issues with the transformer in Van Tassell Substation during the summer. Initially it caused outages across most of our Nebraska territory, but with the ability to tie those members to the Node Substation, we were able to limit the outage time.

Similar to other work plan projects, we are also trying to relocate much of the line as close to the highway, or other roads to improve the access to the lines for patrolling and maintenance. As that line is currently routed, it can be many miles from the road in places, requiring more time to find and fix any issues that arise, while also requiring us to drive through the pastures to get there. It is a win-win if we can get out by the roads and stay clear of pastures where we can.
