## Winter Is Back. Tips For The Season:

### **Treat Frostbite Immediately.**

**Before You Drive.** Clean your car’s external camera lenses and side view mirrors. Remove dirt, ice and snow from sensors to allow the assistive-driving features like automatic emergency braking to work.

Phones are answered 24 hours a day. Phones will be answered by Niobrara Electric Association during office hours and the Niobrara County Sheriff's office will take all other calls and dispatch NEA personnel.

As you can see in the left column, our published office hours are from 7:30 a.m. through 5:00 p.m. Monday through Thursday and 7:30 a.m. through 4:00 p.m. on Fridays. This schedule allows employees every other Friday off. We split the office staff and line crews into two groups so one group gets one Friday and the other, the next. Our Electricians work a 4/10 schedule and are off every Friday.

This schedule works well for employee morale and for scheduling personal appointments. For members who wait until Fridays to handle NEA business however, the individual they call to speak with or stop in to see may be on a Friday off. In order to best serve our members, we ask you to consider making those calls or stopping by earlier in the week. If you are needing contact with an employee that works in the field (line crew member, superintendent, staking, etc) morning visits will net you best results as contact throughout the day may be hit and miss.

We are all here to serve our members everyday of the week. Please never hesitate to call or stop in regardless of the day. Just keep in mind that you may be best served by calling ahead and scheduling an appointment and/or making contact early in the week.
