NEW METERS TO HELP US SERVE YOU BETTER

Referring back to our November 2019 issue, Niobrara Electric Association will be installing new, automated meters over the next few years to increase the efficiency and reliability of our electric system. Improving the efficiency of both operations and electricity delivery can help us keep down costs for members.

The decision to upgrade our metering system came mostly due to the fact that our current system of almost 12 years old, is obsolete and failing. We are no longer able to troubleshoot problems through a customer service representative or get replacement parts for our equipment as those parts are no longer being made.

The new platform we will deploy is the Landis & Gyr Gridstream Automated Metering Infrastructure (AMI) system. This has come with an intensive field study done by our provider Landis & Gyr to strategically place all equipment (collectors, routers, and meters) in a place that will ensure proper communication to gather meter reading information.

With the new automated meters, Niobrara Electric will be able to read meters remotely from the co-op's headquarters, remotely connect and disconnect services at the time of request, detect any meter tampering or power theft, and have faster restoration times as we will be able to pinpoint areas affected by outages and respond quicker. Remote meter reading will save us time, labor, and money.

The new technology can help us monitor the electric system in almost real-time. We can use this information to make the process of delivering power much more efficient. Members can also expect to experience fewer blinks, surges, and spikes as a result of the upgrade. The metering products we have selected have met all FCC requirements. Data retrieval is limited to no more than 1% of each day.

The meters, which provide hourly information about power use, will help consumer members understand how and when they are using electricity. Armed with this information, Niobrara Electric's customer service representatives will be in a better position to help members address billing inquiries.

At Niobrara Electric, taking advantage of new technologies is one more way that we are looking out to better serve our members.


